Dear Troop Leader:

Welcome to the 2024 Girl Scout Cookie Program! Enclosed in this kit is everything you and your troop need to get started.

**Step 1:** Make sure all your girls are registered. Girls must have a 2024 membership to participate in the Cookie Program.

**Step 2:** Appoint a Troop Product Program Manager. This adult will coordinate the sale with you. They must be a registered adult and have a current background check with GSSEM.

**Step 3:** Complete and submit the two financial forms that are required to participate in the Cookie Program. The **ACH Debit Authorization Form:** www.gssem.org/banking and the **Agreement to Assume Debt Form:** www.gssem.org/responsibility. The ACH Form requires an attachment of a void troop check, or a letter from the bank with the troop's account and routing number. If you completed the ACH Debit Authorization form for the 2023 Fall Program, you do not need to submit it again.

**Step 4:** Complete the Cookie Rookie training and review the Cookie Program Troop Handbook and all other enclosed materials. You can complete a recorded Cookie Rookie, training at any time. This training will be available starting December 5, 2023 at www.gssem.org/cookieprogram **or** on gsLearn. Additionally, there are virtual Cookie Rookie trainings:

**Step 5:** Discuss the cookie program with your girls and their parents/caregivers. Inform them of important deadlines, and pass out the Cookie Order Cards, the Family Guide, and all other girl materials. This is also a good time to discuss cookie booths, and cookie program expectations for your troop. Please ask each parent to complete the Product Program Parent Permission Form (located on the back of the Family Guide). You will keep the forms for your records.

**Step 6:** Join the GSSEM Product Program Facebook group for support, guidance, and updates during the program. Log in and search GSSEM Product Program Support.
