Adult Policy Agreement

This agreement is for the attendance of an adult at a GSSEM camp, hereafter referred to as the Attendee.

1. The Attendee agrees to use Camp in accordance with the terms set forth in this agreement, and in the Rental Agreement.
2. The Attendee will abide by the maximum number of people allowed at each unit.
3. The Attendee agrees not to invite guests onto the property who are not included in the group's paid reservation.
4. The Attendee is responsible for cleaning the facilities at the conclusion of the event period as outlined on the departure check-list with the other adults present. The Attendee will leave the facilities and the grounds in clean and proper condition, and in good repair.
5. Any and all expenses incurred by GSSEM as a result of the Attendee's use of the facilities, including breakage or other damage to the facilities, will be billed to the Attendee and shall be due and payable immediately.
6. The Attendee agrees that any personal vehicles, sports equipment, musical instruments, cell phones, tech gadgets, or other valuables are the responsibility of the owner to keep secured at camp. Replacements will not be provided by GSSEM if they are damaged, lost, or stolen.
7. The Attendee agrees that personal sporting equipment (bats, hockey sticks, volleyballs, softballs, baseballs, or other hard sporting equipment) should be stored out of reach of girls until the designated free-time for use in the presence of a supervising adult, for the protection of all attendees.
8. The Attendee is responsible for providing emergency transportation, if needed, for minors under her/his supervision.
9. The Attendee agrees that the Adult-in-Charge is responsible for securing and dispensing all medications the group brings during the event period. Medications should be secured and kept out of reach of girls at all times with the exception of rescue inhalers and Epi-pens.
10. The Troop Leader/Adult-in-Charge is responsible for the supervision of the Group and the behavior of all attendees. The Attendee may not engage in activities and/or behaviors that, in the judgement of GSSEM, may damage the public image of Girl Scouts.
11. The Attendee will comply with all applicable laws, local safety and fire regulations, and Girl Scout regulations as outlined in the check-in packet received upon arrival. The designated Adult-in-Charge of the group, is responsible for ensuring that all participants are oriented to the safety rules as they apply to the site and facilities.
12. The Attendee agrees not to bring any pets of any kind on to the property.
13. The Attendee agrees that alcohol, illegal drugs, and firearms are prohibited on any premises owned by GSSEM. The Attendee agrees that GSSEM facilities are smoke-free (including vaping) both indoors and outdoors and that smoking must take place off-site.
14. This Adult Policy Agreement is the entire agreement between GSSEM and the Attendee and supersedes all prior agreements.
