PURPOSE OF THIS FORM

- GSSEM provides financial assistance to help girls attend Summer Camp.
- All girls are expected to participate in the yearly Cookie Program to earn funds to pay for expenses the following year.
- Financial assistance is only available when all Girl Scout finance accounts are current.

INSTRUCTIONS

If you're applying for membership dues assistance for your daughter

- Fill out the "Information" and "Membership" sections
- Sign your name in the "Applicant Signature" section at the bottom of page three.
- Attach the completed membership application available on our website
- Submit all forms by fax or email attachment as instructed at the "Sending in Your Forms" section at the bottom of page three.

Applying for assistance for Summer Camp:

- Complete all three pages and sign your name in the "Applicant Signature" section.
- Select on page two which Summer Camp(s) you are applying for (Please check our website)
- Attach a document that verifies your finances (see the "Financial Resources" section on page three for requirements). We encourage you to cover/black out your social security information.
- Submit all forms by fax or email attachment as instructed at the "Sending in Your Forms" section at the bottom of page three.

Please allow two to three weeks for processing.

Upon approval, you'll receive a letter at the address you provide in the following section. The letter will include 1) your approved financial assistance, 2) the dollar amount, and 3) further instructions.
